9. Buyer authorizes, in advance, the Buyer's lender to release a copy of the appraisal to the Seller.

10. Buyer must provide documentation from the lender verifying appraisal was ordered within 6 business days from acceptance, if Buyer is obtaining financing.

11. Should escrow not close on COE date, due to no delay by Seller, Buyer shall pay \$100 per diem late closing fee until the actual date of closing. Per diem charges start on 3rd day. Seller will waive per diem fee if Gem Mortgage is used for financing.
