

- A. The seller's has a minimum acceptable bid price. List price may not be the minimum acceptable bid price.
- B. The auction is being conducted with the seller's right of reservation
- C. The property is being sold through Homesearch.com.
- D. All required procedures for Participants/Subscribers to register their representation of a potential bidder:

To Register with Xome.com (<https://www.xome.com>):

Go to Xome.com. Registration links are located throughout the site, located on the top right corner. Click "sign in" and complete the online registration form and submit your information. Don't forget to also sign up for alerts, which are customizable to your property preferences. The "Property Alerts" signup is also located throughout the site on the bottom right corner of each page.

To Register to submit a bid on a specific property (<https://www.xome.com>):

There are no fees to bid; however, you must register for the auction event. During the event registration we may place a hold of \$2,500 on your credit card before you can place bids on properties within the event. If you do not purchase a property, the hold will be removed within 24 hours after the event ends. If a property is purchased, the hold will be held until your earnest money has been received by the escrow/closing company, at which time your hold will be released. - G. The seller will allow pre-auction bids through the [www.Xome.com](http://www.Xome.com) website. When on the auction page, click the 'Make Offer' button in order to submit the offer. The compensation in Section E still applies.
