The company is authorized to proceed with the work outlined in the items circled below from the Termite Inspection Report for the property inspected, for a total sum of This total amount is due and payable within 5 days from completion repair work and/or chemical application.

THE COMPANY AGREES

To guarantee all repair completed by this company for one year from date of completion except for caulking, grouting, or plumbing, which is guaranteed for a period of ninety (90) days. We assume no responsibility for work performed by others, to be bound to perform this work for the price quoted in our cost breakdown for a period not to exceed 30 days, to use reasonable care in the performance of our work but to assume no responsibility for damage to any hidden pipes, wiring, or other facilities or to any shrubs, plants, or roof.

THE OWNER OR OWNER'S AGENT AGREES

To pay for services rendered in any additional services requested upon completion of work to pay a service charge of one and one-half percent (1 1/2%) interest per month, or portion of any month, annual interest rate of eighteen percent (18%) on accounts exceeding the ten (10) day full payment schedule. The Owner grants to The Company a security interest in the property to secure payment sum for work and inspection fee completed. In case of non-payment by The owner, reasonable attorney fees and costs of collection shall be paid by owner, whether suit be filed or not.

ALL PARTIES AGREE

If any additional work is deemed necessary by the local building inspector, said work will not be performed without additional authorization from owner or owner's agent. NOTICE TO OWNER

Under the California Mechanics Lien Law, any structural pest control company which contracts to do work for you, any contractor, subcontractor, laborer, supplier or other person who helps to improve your property, but is not paid for his or her work or supplies, has a right to enforce a claim against your property. This means that after a court hearing, your property could be sold by a court officer and the proceeds of the sale used to satisfy the indebtedness. This can happen even if you have paid your structural pest control company in full if the subcontractor, laborers or suppliers remain unpaid.

To preserve their right to file a claim or lien against your property, certain claimants such as subcontractors or material suppliers are required to provide you with a document entitled "Preliminary Notice." Prime contractors and laborers for wages do not have to provide this notice. A Preliminary Notice is not a lien against your property. Its purpose is to notify you of persons who may have a right to file a lien against your property if they are not paid.

- 7. The occupant must soak the soil with water at least 12 inches from foundation outward. This can be done the evening before and may help to protect plant root growth. Cut back plant growth where possible 12 to 18 inches away from exterior of building(s), this includes ivy, vines and bougainvillea. If debris is not cleared away and vines and trees are not trimmed, the crew might not get a good ground seal with the tarps. Plants, vines, grass etc. that might be covered during fumigation might die. Climbing plants, fences, trellises and vines not detached from the building may be subject to damage. The fumigator will not be held liable. Water and electricity must be turned on during fumigation. All automatic devices (sprinklers, fixtures or other items) must be turned off. Next Generation Fumigation will not be responsible for damages to lightning fixtures and other items that project from the structure
- The occupant <u>must turn off</u> any <u>air conditioning</u> units and heaters, thermostat operated or otherwise. If any burglar alarms are to be left on, leave instructions on operation; movement alarms must be turned off.
- ACCESS IS REQUIRED BY LAW. We must have access to all areas within the structure, including rooms or garages kept locked. PLEASE MAKE KEY
 ARRANGEMENTS BEFORE THE DAY OF THE FUMIGATION AND PROVIDE INSTRUCTIONS ON WHERE YOU WOULD LIKE THE KEYS
 TO BE LEFT UPON COMPLETION. If walk-in or large safes exist you must be present to open them for our inspection.
- 10. We request that the home owner or occupant remove antennas and/or satellite dishes where possible; if we must remove them, we will assume no responsibility for damage or alignment. Old And oxidized antennas are usually damaged when they are removed or replaced
- 11. The occupant should slightly open all drawers, cabinets and closets prior to the fumigation to ensure complete gas ventilation. This is required by the State regulatory agency.
- 12. Where gas refrigerators exist, the occupant should allow for defrosting during the fumigation, as all gas will be turned off
- 13. In cases where gas pilots will not remain lit after lighting, or where heater, water heater or oven are old, and special expertise is needed in lighting, we will request that you contact the gas company to come and relight the pilot.
- 14. 4. Our crews must furnigate several structures in various locations each day. We provide a call for every job. Each job presents its own unique challenges and our crews are also subject to traffic conditions, therefore, any time of day for the furnigation to be scheduled will be an approximate time only.
- 15. Furnigations require the use of masking tape. Where the painted surface is old, oxidized, or improperly applied, peeling or chipping will occur. Even though these surfaces appear to be in good condition we assume no responsibility for any damage.
- 16. The roof surface and perimeter areas of the building must be walked upon, and damages may occur, although the utmost care will be exercised. Neither the termite company nor its licensed fumigator will assume any liability for such damage or consequential damage that may occur to roofs or roof coverings and areas below roofs. Also Included are gutters, electrical wiring, patio and awning covers, solar heating panels or related plumbing, and living plants or landscaping at/adjacent to the subject property.
- 17. During the fumigation and aeration period, the possibility of burglary exists as it does any time you leave your home; therefore, we recommend you take any steps you feel necessary to prevent this. We do not provide on-site security during the fumigation procedure or after the tent(s) or seals are removed. Our insurance does not cover malicious vandalism or theft. We will not be responsible for any losses or stolen items. It is in your best interest that all valuables be removed before fumigation.
- 18. Next Generation Fumigation assumes no responsibility for damages resulting to or from structure not built to construction codes.
- If tarping of the building requires entrance into your neighbor's yard by the crew, pets must be removed or tied up. Please inform your neighbor and secure written permission to enter their property.
- 20. Old gas and water pipes may be damaged during the furnigation. Next Generation Furnigation is not responsible for such damages. Gas and water pipes in good condition will not be damaged. Next Generation Furnigation assumes no liability for resulting from faulty gas meters. We are not responsible for damage to old or faulty furnaces and water heaters resulting from re-lighting procedures.
- 21. I/we the undersigned have read, reviewed and agree to all the provisions contained herein and have acknowledged receipt of an exact copy of the 'Occupants' Furnigation Notice.' In case that I/we do not comply with the requirements as stated herein, I/we agree to hold the termite operator and the furnigation licensee harmless of any liabilities connected with the furnigation procedure. I/we further stipulate that If the building(s) have tenant occupants that I/we, or our authorized agent or manager, has/will distribute copies of this Notice to all such occupants by the use of U.S. mail, posting on the front door, or hand direct delivery. As you prepare your home for its upcoming fumigation, we wanted to remind you of a sometimes-overlooked family member- your cat. Cats are unique pets as they have a propensity to come and go as they please. Unlike a dog, cats prefer to be left with little to no attention to them. Having this freedom causes a variety of reactions when your pet becomes stressed. You many have noticed that as their environment changes or as a stranger enters their environment your cat may act odd or run and to hide more, sometimes making them impossible to find prior to the home being fumigated. Sometimes the homeowner is so distracted in completing their preparations and hope to remove their pet. The unfortunate ending is the loss of a loved one. Next Generation Fumigation, hopes to prevent this from happening to your family roams the neighborhood. To help reduce the chances of their pet entering the structure during the fumigation process, we strongly recommend that you communicate your fumigation dates with your neighbors and close off any opening to spaces that would allow domestic animal access, such as exterior sub area vents, access openings or additional vents Next Generation Fumigation, utilizes chloropicrin (tear gas) as a warning agent and Vikane gas, during fumigation. OWNER OR AGENT IS RESPONSIBLE FOR THESE COSTS, SO BE SURE THAT EVERYTHING IS READY WHEN THE FUMIGATORS ARRIVE.

WARRANTY

NEXT GENERATION FUMIGATION WARRANTS AGAINST THE REAPPEARANCE OF DRYWOOD TERMITES OR BEETLES IN THE AREAS NOTED IN THE ORIGINAL TERMITE INSPECTION REPORT FOR A PERIOD OF THREE (3) YEARS FROM THE DATE OF THE FUMIGATION. THE METHOD OF RETREATMENT IS SOLELY WITHIN THE DISCRETION OF NEXT GENERATION FUMIGATION A ND MAY BE LOCALLY TREATED OR THE STRUCTURE MAY BE REFUMIGATED. REGARDLESS OF THE TREATMENT, THE OWNER SHALL BE OBLIGATED TO PAY FOR ALL COSTS OF PREPARATION IN CONNECTION WITH THE TREATMENT. IN THE EVENT THAT NEXT GENERATION FUMIGATION NOTICE AND DISCLAIMER. IN THE EVENT THAT NEXT GENERATION FUMIGATION REQUIRES THE EXECUTION OF RELEASES BY OWNER FOR DAMAGES TO THE ROOF, OTHER STRUCTURES OR VEGETATION AS A RESULT OF THE PREPARATION OR TREATMENT, THE OWNER AGREES TO EXECUTE ANY RELEASES. THIS WARRANTY DOES NOT EXTEND TO ANY EXPENSE INCURRED BY THE OWNER, HIS OR HER AGENT OR HIS OR HER TENANT IN CONNECTION WITH ANY SUCH TREATMENT, NOR DOES THE WARRANTY EXTEND TO COVER ANY RESTITUTION FOR ANY INCONVENIENCE CAUSED BY TREATING THE STRUCTURE.
