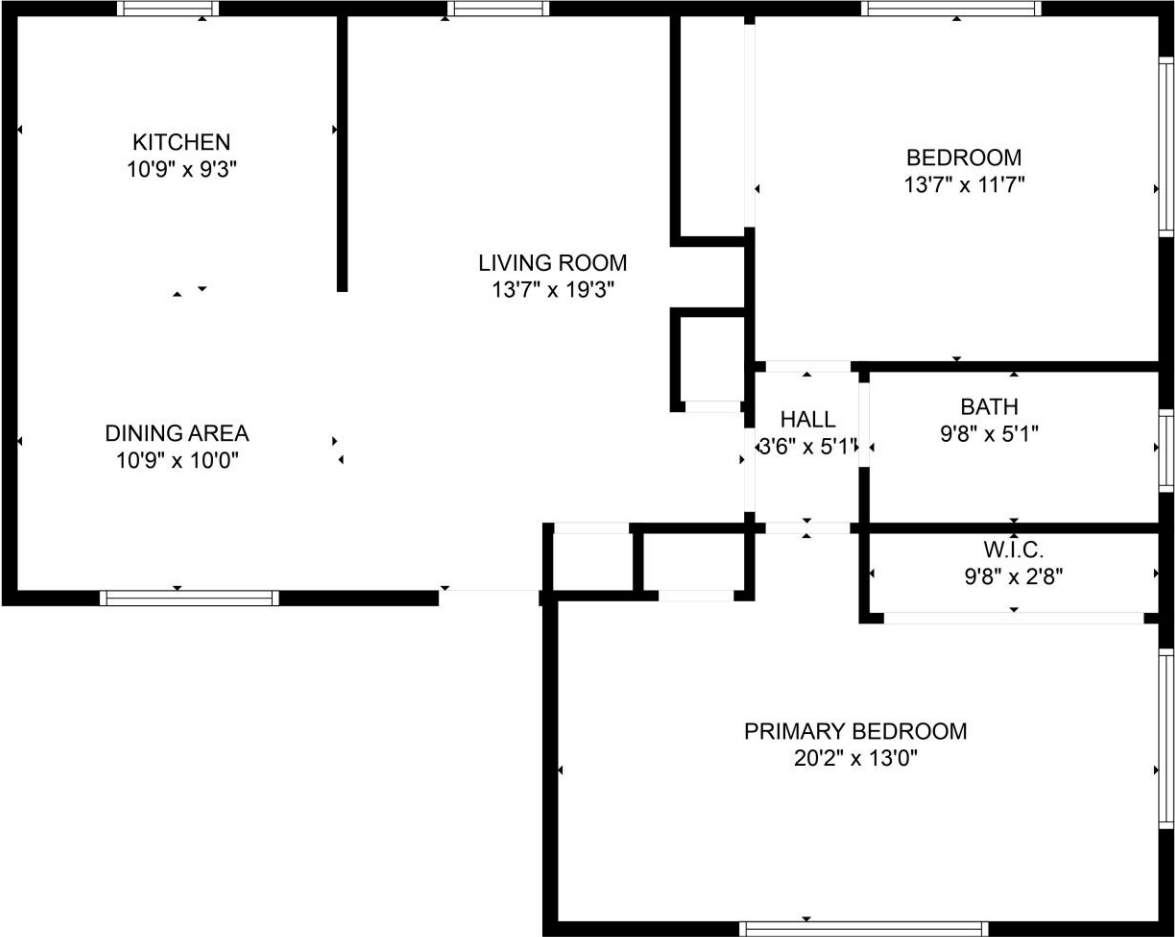

Unit 4 Floorplan: 2-Bed



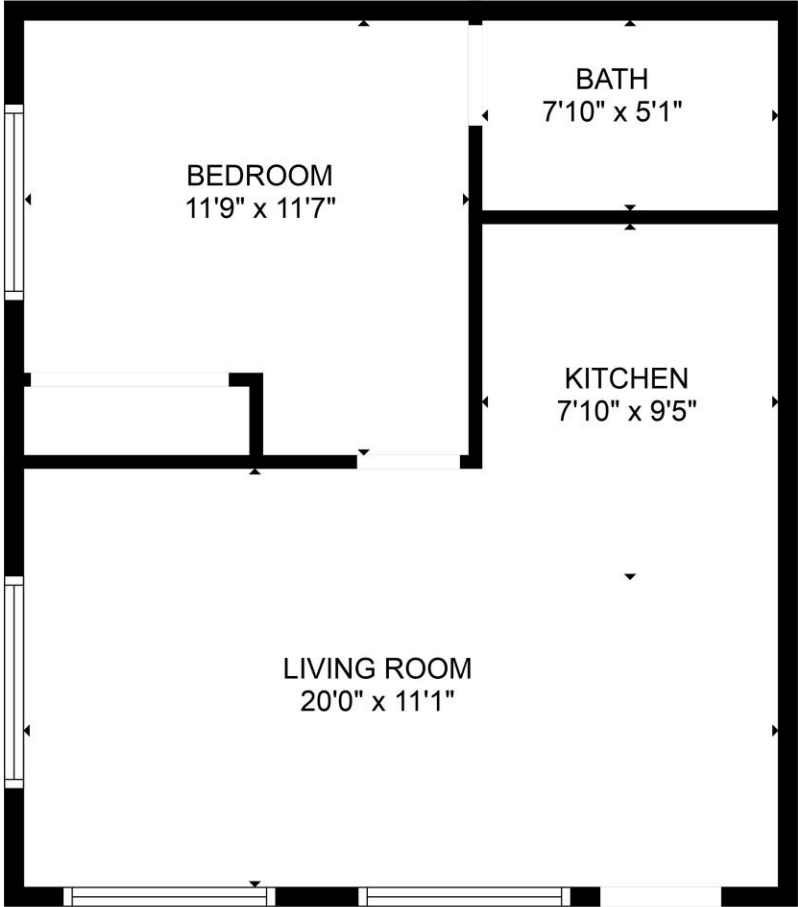

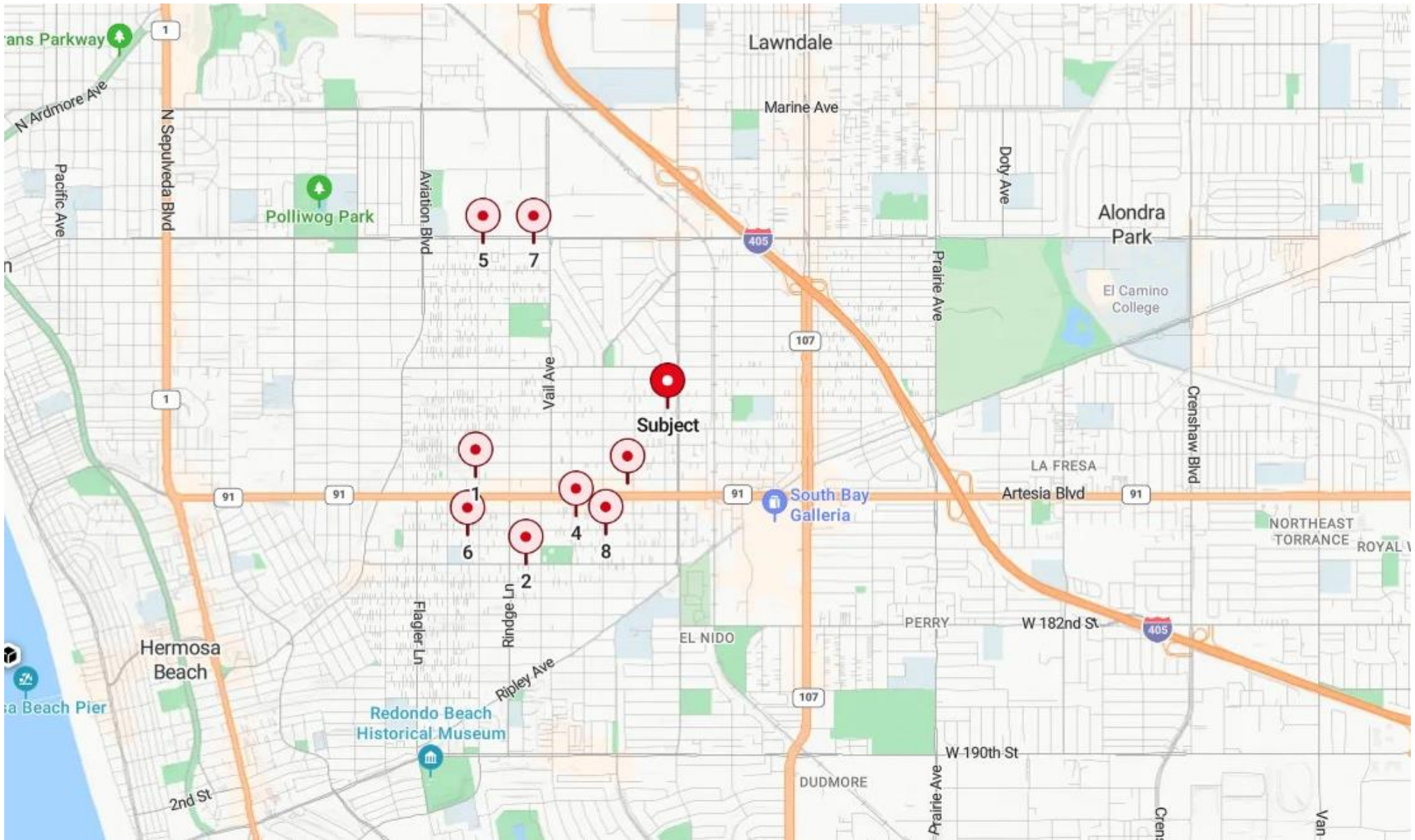

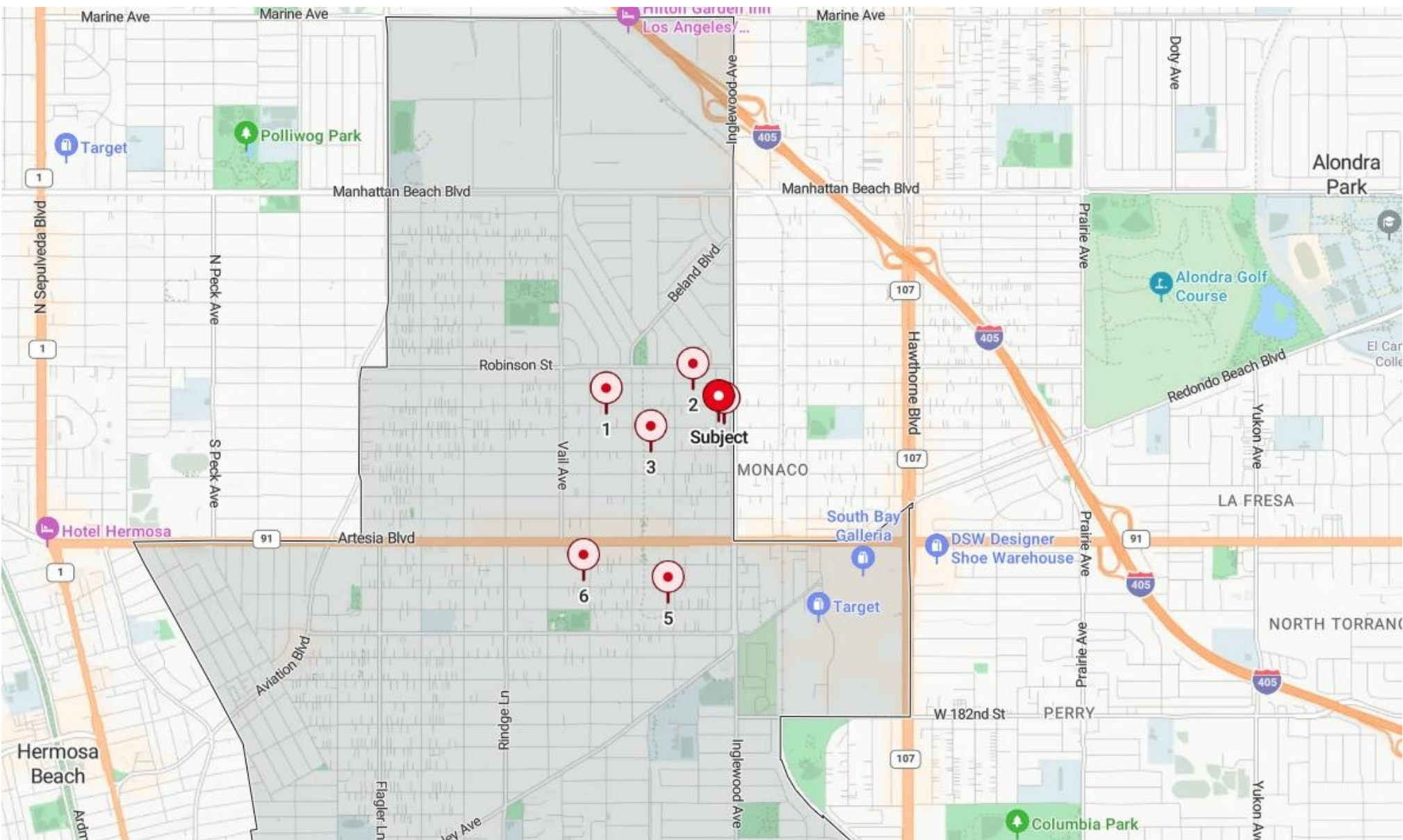

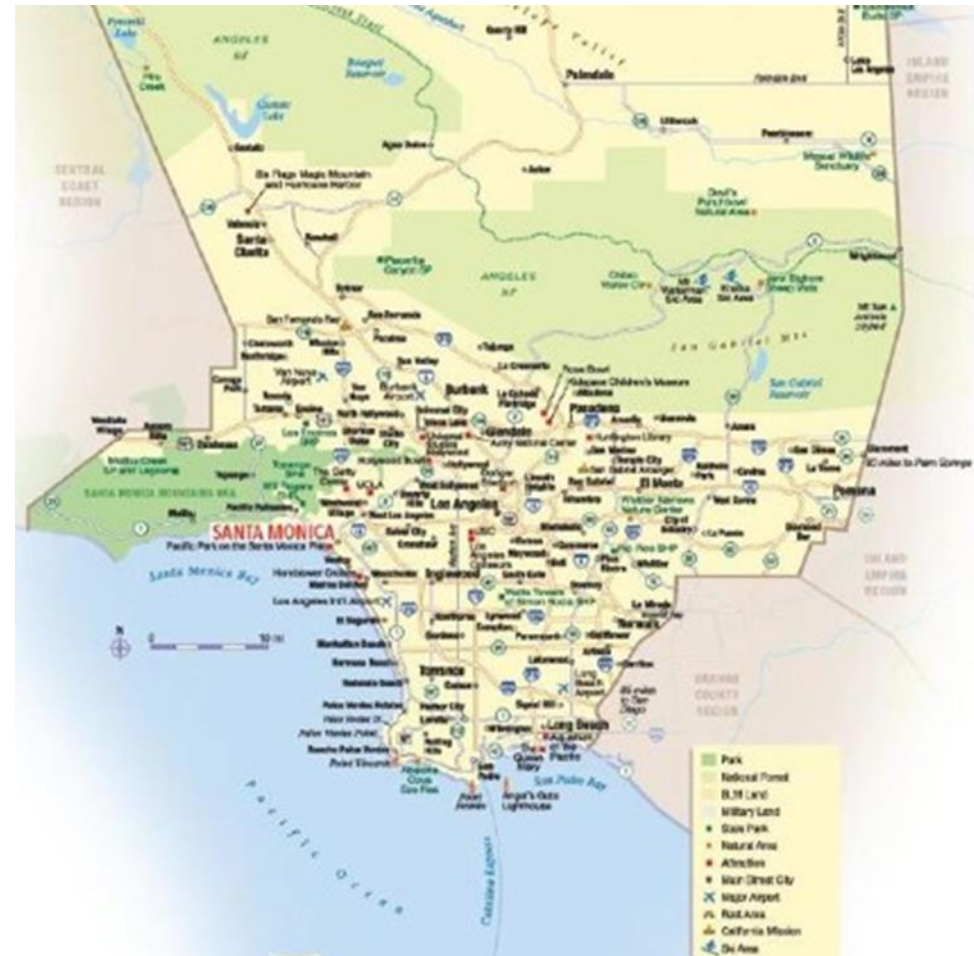


Los Angeles

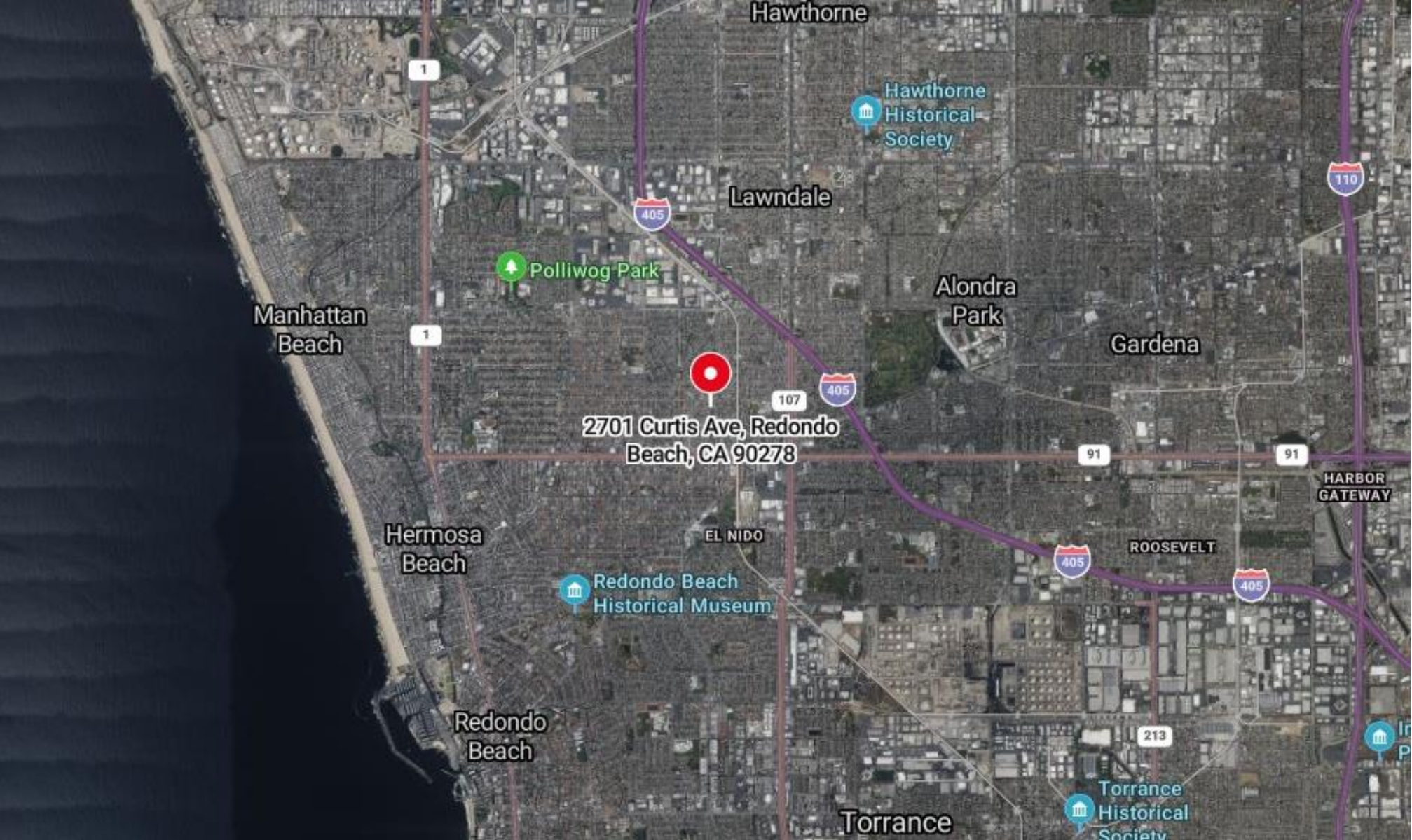

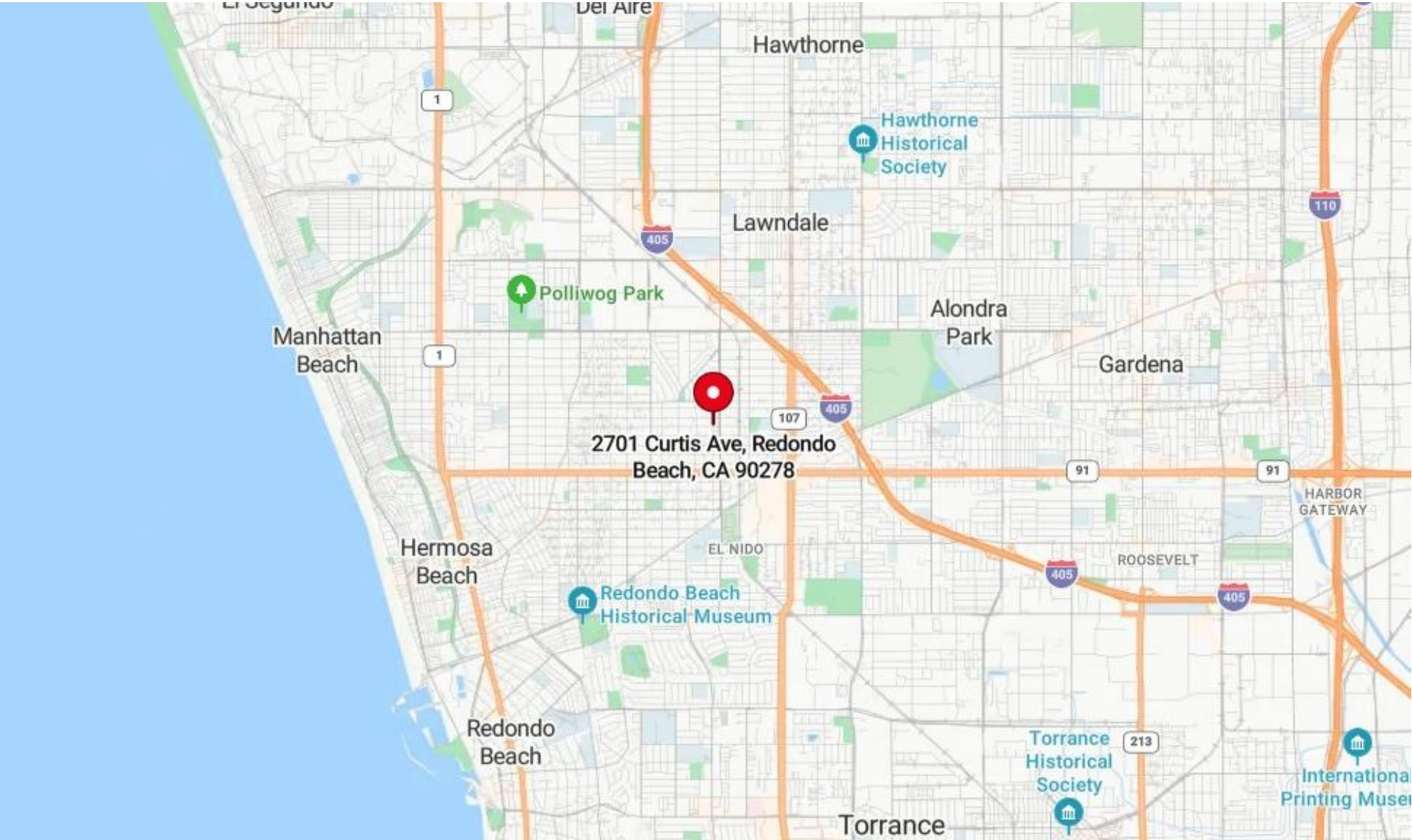
Local Map
