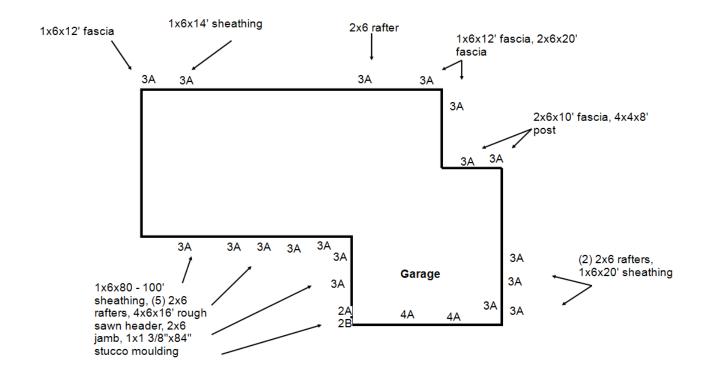

What is a Wood Destroying Pest and Organism Inspection Report?

The following explains the scope and limitations of a structural pest control inspection and a Wood Destroying Pest & Organism Inspection Report.

A Wood Destroying Pest & Organism Inspection Report contains finding(s) as to the presence or absence of wood destroying insects and/or organisms in visible and accessible areas on the date of inspection and contains our recommendations for correcting any infestations, infections, or conditions found. The contents of the wood destroying pest & organism inspection report are governed by the structural pest control act and its rules and regulations.

Some structures may not comply with building code requirements or may have structural, plumbing, electrical, heating and air conditioning, or other defects that do not pertain to this report. This report does not address any such defects as they are not within the scope of the license of the inspector or the company issuing this report.

The following areas are considered inaccessible for purposes of inspection or are not included in a normal inspection report and therefore are excluded because they are considered inaccessible for purposes of inspection, including but not limited to, in this report: (1) the interior of hollow walls; (2) spaces between an upstairs floor and the ceiling below or a porch deck and soffit below; (3) stall showers over finished ceilings; (4) such structural segments as areas enclosed by bay windows, buttresses, abutments, columns, built-in cabinet work, areas under floor covering; (5) any areas requiring the removal of storage, furnishings or appliances; (6) any areas to which there is no access without defacing or removing lumber, masonry or finished workmanship, (7) detached structures ie: patios, decks, retaining walls, wood walkways, (8) fences and gates surrounding or attached to the property.

A visual inspection was performed of the second story eave area(s) from the ground level. Area(s) were not probed due to height. The exterior is inspected from the ground level only.

Certain areas are recognized by the industry as inaccessible and/or for other reasons not inspected. These include but are not limited to: inaccessible and/or, insulated attics or portions thereof, attics with less than 18" clear crawl space, the interior of hollow walls; spaces between a floor or porch deck and the ceiling below; areas where there is no access without defacing or tearing out lumber, masonry or finished work; make inspection impractical; and areas or timbers around eaves that would require use of an extension ladder.

Certain areas may be inaccessbile for inspection due to construction or storage. We recommend further inspection of areas where inspection was impractical. Re: Structural Pest Control Act, Article 6, section 8516 (b), paragraph 1990 (l). Amended effective March 1, 1974. Stall shower, if any, are water tested in compliance with Section 1991 (12) of the Structural Pest Control Act. The absence or presence of leaks through sub-floor, adjacent floors or walls will be reported. This is a report of the condition of the stall shower at the time of inspection only, and should not be construed as a guarantee. Although we make a visual examination, we do not deface or probe into window or door frames, decorative trim, roof members, etc., in search of wood destroying pests or organisms.

"This company will reinspect repairs done by others within four months of the original inspection. A charge, if any, can be no greater than the original inspection fee for each reinspection. The reinspection must be done within ten (10) working days of request. The reinspection is a visual inspection and if inspection of concealed areas is desired, inspection of work in progress will be necessary. Any guarantees must be received from parties performing repairs."

If your home is equipped with a pressurized fire sprinkler system and/or (PEX) polyethylene pressurized water supply system, you are advised to employ a licensed C-16 fire-protection contractor and/or licensed C-36 plumbing contractor to drain and disable the pressurized system(s) before our employees or subcontractors can gain access to the attic for any inspections, repairs or treatments. Due to the fragility of pressurized fire sprinkler system and/or (PEX) polyethylene pressurized water supply systems Acme Termite Company Inc cannot accept responsibility for damage to the system that may by caused inadvertently by our activities in the attic. Your C-16 fire-protection contractor and/or licensed C-36 plumbing contractor will need to inspect and re-establish the system after we have finished the work you have hired us to do in the attic.

In the event of a fumigation or re-fumigation please note that fumigation dates may change due to unforseen circumstances, including inclement weather, wind, rain, etc. Should Acme Termite Company Inc, and/or it's subcontractor, determine the fumigation should be delayed because of inclement weather (wind, rain, etc.), the fumigation will be rescheduled to a mutually agreeable date without penalty for any costs incured by owner and/or owner's agent. In the event of a fumigation or re-fumigation, Acme Termite Company Inc and/or it's subcontractor are not responsible for the costs relating to "move-out" or preparation costs including but not limited to moving or hotel costs, pet boarding, food removal/loss, roof damage, plant damage, satellite dish damage, any antenna damage or other costs that may be associated with the fumigation process.

Acme Termite Company Inc is not responsible for any foliage damaged due to fumigation. Zero-Lot Line properties must obtain neighbor's permission on a form provided by us for fumigation to commence and owner/agent is responsible for obtaining neighbor's signature on the form. Acme Termite Company Inc does not provide security for fumigation. Valuables must be removed from structure prior to fumigation. Acme Termite Company Inc takes the utmost care in providing for a fumigation however by agreeing to this report you are also agreeing to hold Acme Termite Company Inc harmless and not responsible for any damage done to your property or for any chattel stolen in the event of a criminal act committed to the property being fumigated due to a fumigation job. In the event a fumigation is cancelled the day that the job is scheduled for, a \$300 non-refundable fee will be added to your job. In the event a fumigation is cancelled 25 to 48 hours prior to the day of the scheduled fumigation job, a \$200 non-refundable fee will be added to your job. AC UNITS must be TURNED OFF - often times the crew will remove fuses to insure the AC Unit does not come on automatically, by agreeing to this report, the owner and/or owner's agent is responsible for replacing the fuses in the AC Unit and agrees to be responsible if owner or owner's agent calls for a 3rd party AC Service company to replace or reinstall fuses or get the AC Unit operating again after a shut-off due to fumigation. The crew will attemp to reinstall the fuses but sometimes they forget, if the owner finds that the AC Unit is not working after a fumigation, you agree that you are to call us to give us the opportunity to replace the fuses.

CONDITIONAL GUARANTEE: Acme Termite Company Inc guarantees all work performed by this company for one year, unless otherwise stated in the body of this Report, with the exception of plumbing, grouting, caulking, resetting of toilets, resetting of enclosures, or floor coverings, which are guaranteed for 30 days and are considered Owner maintenance areas. This company is not responsible for any future infestation, dry rot or adverse conditions beyond the time of inspection. In the event of a Fumigation: Property owner is responsible to verify the scheduling of the natural gas service turn off & restore, by their local natural gas company. Acme Termite Company Inc and/or it's subcontractor will facilitate, as a courtesy, the scheduling of the natural gas turn-off & restoration. The owner MUST be physically present when the gas company service technician comes to restore the natural gas service to the property, which means: the owner or their agent, being 18 years or older, MUST be at the property on the day the fumigation tent comes off & to allow the gas company representative access to restore gas service. If the natural gas company technician arrives and there is no one at the residence to allow them access, the gas will NOT be restored at that time, and another appointment MUST BE MADE BY the owner/agent for gas restoration at a future date. (Gas Companies require 48 hours to schedule an appointment for a fumigation gas restore)

- a FIVE working DAYS notification (Definition of working days is MONDAY - Friday = working days) IS REQUIRED to shut off the gas meter. CALL US FOR APPOINTMENT AVAILABILITY IF SHORTER NOTICE IS DESIRED.

Long Beach Energy Resources Department WILL NOT restore gas service the same day the tent is removed.

Fume tents removed on Friday can be restored on Satruday provided the premise has been cleared for re-entry.

Access to the natural gas meter on Fumigation Day required !!! No Access = NO FUMIGATION

Owner or Owner's Agent that is 18 years or older REQUIRED to be present on RESTORE DAY (time frames for retore is 12p - 8p, yes you may be waiting a long time)

Natural Gas SHUT-OFF and RESTORE service is scheduled as a courtesy and is free, YOU are ultimately RESPONSIBLE for making sure you're available and natural gas meter access is available as necessary to facilitate this so that we can fumigate. BY Signing this agreement on the last page, you are also agreeing to hold harmless Acme Termite Company Inc and / or it's employee(s) and / or subcontractor(s) from complications that may arise out of scheduling conflicts and / or getting the natural gas service restored, ie: it's an Air BnB and you have guests scheduled, and on the day the restore is scheduled, you have an unforseen circumstance that prevents you from being present to allow restoration of the natural gas service.

TO REITERATE TO MAKE SURE YOU UNDERSTAND:

Owner or Owner's Agent that is 18 years or older MUST BE PHYSICALLY PRESENT when natural gas service is scheduled for restore to allow access to the interior. Time Frames for Natural Gas Restoration service can range from 12 pm to 8pm. The time frame is given out by the natural gas companies per their policy, not us, we are simply relaying their requirements.

This is a separated report which is defined as Section I/Section II conditions evident on the date of the inspection. Section I contains items where there is visible evidence of active infestation, infection or conditions that have resulted in or from infestation of infection. Section II items are conditions deemed likely to lead to infestation or infection but where no visible evidence of such was found. Further inspection items are defined as recommendations to inspect area(s) which during the original inspection did not allow the inspector access to complete the inspection and cannot be defined as Section I or Section II.

Stall Shower: First story stall tested as per section 1991.1(12) and not leaking on date of inspection. If present, second story stall shower(s) are not inspected due to finished ceilings. Any fiberglass or concrete shower bases on any story are not inspected.

FINDINGS: Evidence of drywood termite infestations at garage as indicated on the diagram.

Remove and replace weather stripping, if new weather stripping required due to condition of existing, additional charge applies. FINDINGS: Dry-rot/Fungus Infection wood members found at time of inspection at exterior eaves at 4x6x16' header, (5) 2x6x12' rafters, 1x6x120' sheathing, (4) 2x6 rafter tails, 2x6x30' fascia, 1x6x40' fascia, (2) 2x4x8' wall studs at garage, 4x4x8' post as indicated on the diagram.

RECOMMENDATION: Replace dry-rot/fungus damaged wood members as necessary. Treat new lumber with State registered termiticide/fungicide. Prime and finish paint new lumber as necessary prior to installation included in estimate. Upon removal of visible and accessible damage, if further damage currently inaccessible is noted, a supplemental report will be issued along with additional estimate to correct. Dispose of construction related debris at proper waste facility. Removing asphalt shingles required to access dryrot/fungus damaged members, if existing shingles are not able to be re-used due to current condition, additional charge applies to acquire new asphalt shingles, exact color not guaranteed to match due to fading of existing shingles from sun/weather. We will communicate the condition of asphalt shingles as repair is in progress and report on additional charges on a Supplemental report to interested parties for approval prior to proceeding with the rest of the work. Estimate includes repairing stucco damage that may occur during replacement of 4x6 header and 2x6 rafters.
