Owner acknowledges receipt of a completed, legible copy of this agreement including the TERMS AND CONDITIONS hereof.

Plaster the pool with a mixture of white cement and white marbled pool mix. The material is machine applied, following the gunite and hand troweled to a smooth finish. With three (3) coats of plaster, the plaster will be guaranteed for a period of _____ from any separation from the existing surface to the new plaster, the plaster conditions. There is no guarantee against chemical discoloration or staining as this is normally the result of improper maintenance. There is no guarantee damage because of earth movement, earthquake or structure of the pool.

Fill the pool with a water hose. Supply your own water hose, long enough to reach from the water faucet to the main drain of pool or spa. Stop all irrigation systems around the pool area until pool and, or spa is full. Do not stop the water for any reason whatsoever until it reaches 2" inches up the tile line, otherwise a ring mark will appear on the new plaster. Once the pool is full, contact your pool man to do the start up. Brush the pool and spa walls, steps, benches, corners and floors two times a day for the first ten (10) days. Do not turn the hot water heater on for the first ten (10) days. Do not get in the pool or spa until water is clear and has the right chemical balance (7 days). Once you get in pool or spa you are recommended to wear socks for the first fifteen (15) days. Do not let pets in the pool or spa for the first thirty (30) days.

The work is guaranteed to be completed in a workmanlike manner according to regular practice, and will be completed as near as possible to ten (10) working days. The guarantee will become void if the pool is drained and repaired during the guarantee period by any other than Reyes Pool Plastering Inc. We appreciate your trust in us, and we will continue to give you the service you deserve, the best in the business.

NOTICE TO OWNER (Section 7018 7019-Contractors License Law)

Under the Mechanics' Lien Law any contractor, subcontractor, laborer, materialman or other person who helps to improve your property and is not paid for his labor, services or materials has a right to enforce his claim against your property. This means that after a court hearing, your property could be sold by a court officer and the proceeds of the sale used to satisfy the indebtedness. This can happen even if you paid your own contractor in full, if the subcontractor, laborer or supplier remains

Under the law you may protect yourself against such claims by filing before commencing such work of improvement, an original contract for the work or improvement or a modification thereof, in the office of the county recorder of the county where the property is situated and requiring that a contractor's payment bond be recorded in such office. Said bond shall be in an amount not less than fifty percent (50%) of the contract price and shall in addition to any conditions for the performance of the contract be conditioned for the payment in full of the claims of all persons furnishing labor, services, equipment or materials for the work described in said contract.
