PRELIMINARY REPORT

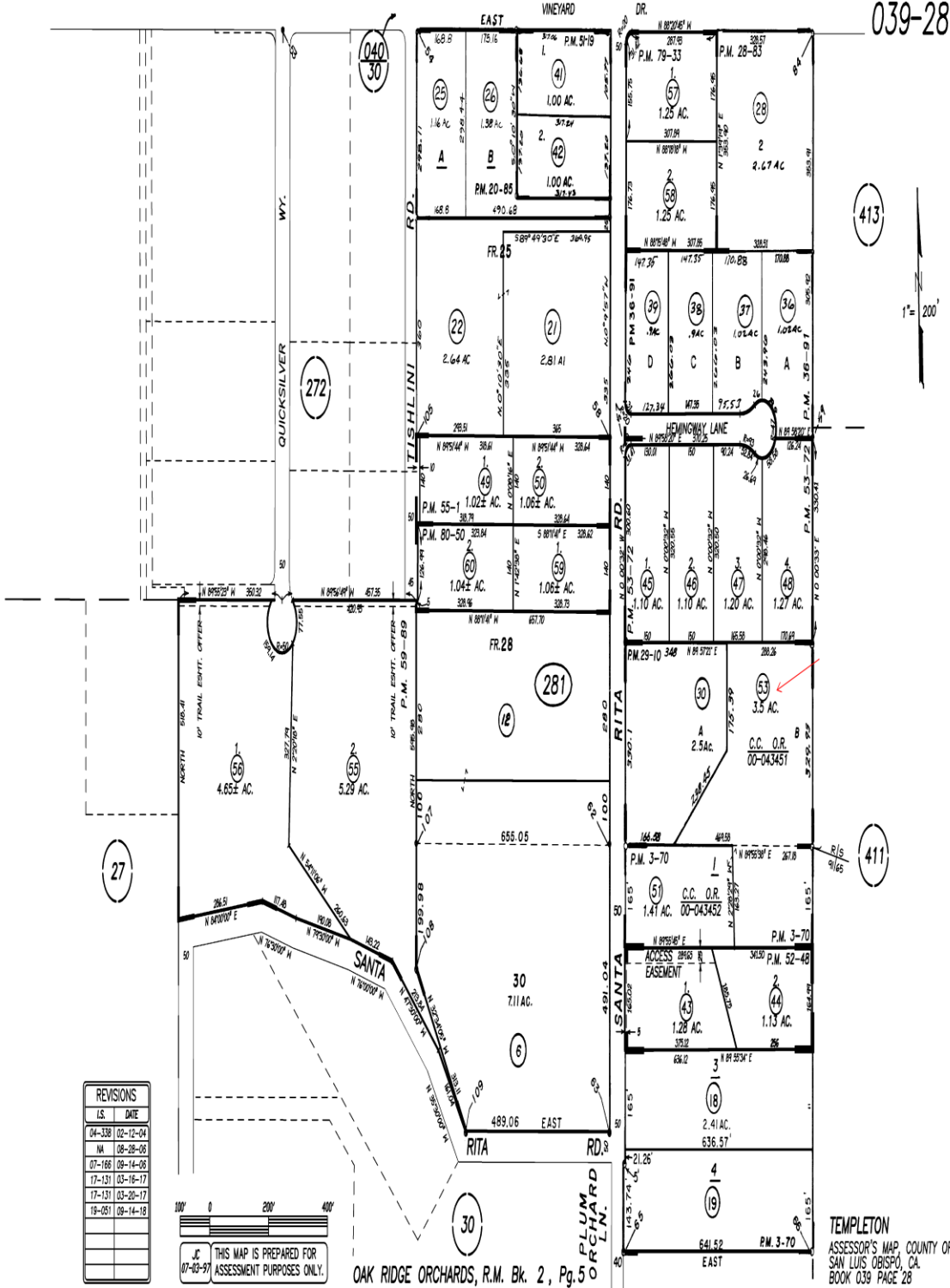
