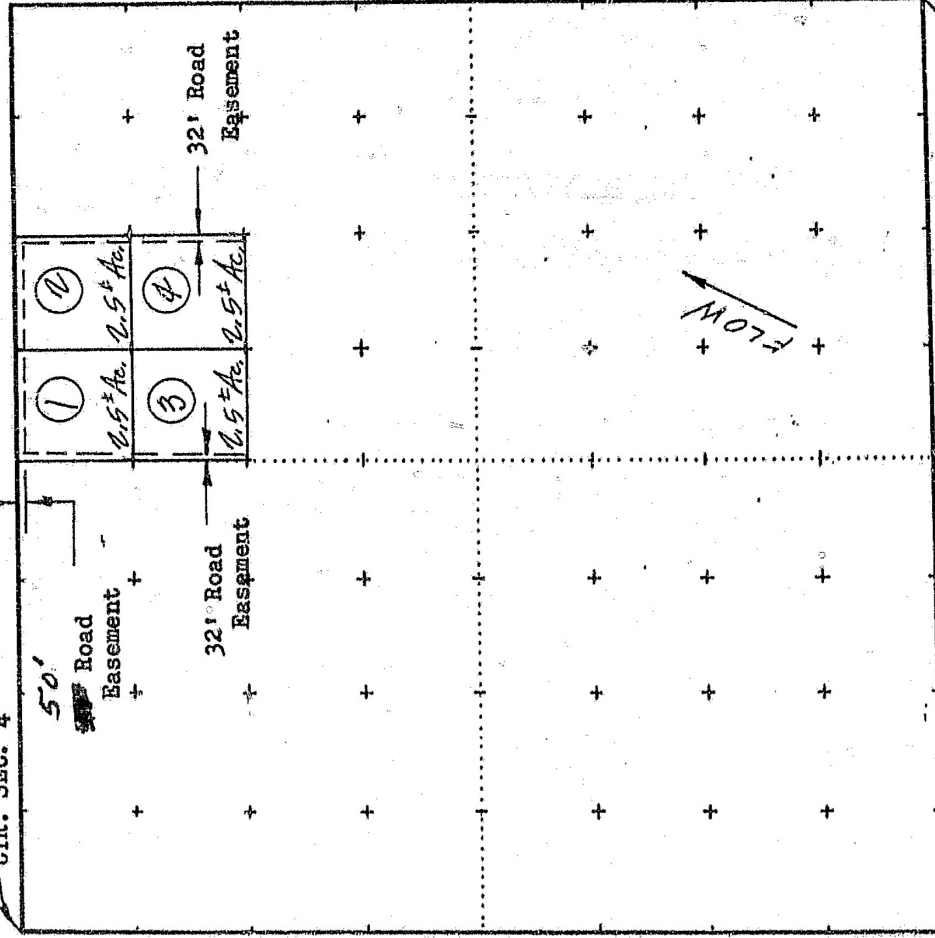
PLOT PLAN MAP
