1. SEAL ALL EXPOSED NAILS ON THE FLASHINGS.
2. SECURE AND SEAL SOME NAILS THAT ARE COMING THROUGH THE COMPOSITION.
3. SEAL ALL A/C STAND BOLTS.
4. REMOVE ALL OF THE DEBRIS FROM THE VALLEY SYSTEMS.
5. REMOVE ALL OF THE DEBRIS CAUSED BY THE REPAIRS.
6. PROVIDE A TWO YEAR CERTIFICATE.

NOTE: THE FIREPLACE FLUE IS TILTED AND NEEDS RESET BY A PROFESSIONAL.

NOTE: THE SOUTH SECTIONS HAS SOME FIBERGLASS ON THE EDGES OF THE DIMENSIONAL SECTIONS OF THE SHINGLES. THIS DOES NOT AFFECT THE WATER TIGHTNESS OF THE ROOF BECAUSE IT IS IN EARLY STAGES.

*Any balance not paid within 14 days shall accrue a finance charge of 1% per month or to the maximum rate allowed by CA law, whichever is less. Customer agrees to pay all reasonable costs of collection permitted by law, including administrative fees and collection costs, should the account become delinquent.

Additional costs may accrue if work requires modifications, upgrades, inspections, or permits necessary to comply with applicable California building codes, safety standards, or permitting requirements. No work will be performed beyond the original scope without client authorization, except where required for immediate safety or legal compliance.

INSURANCE DISCLOSURE

Contractor maintains workers' compensation insurance as required by California law. Contractor also maintains commercial general liability insurance for bodily injury and property damage arising from contractor operations. Insurance coverage does not extend to pre-existing conditions, concealed damage, or conditions outside the agreed scope of work.

LIMITATION OF RESPONSIBILITY

To the fullest extent permitted by California law, Client releases, waives, and agrees to hold harmless Contractor, its owners, officers, employees, and subcontractors from any and all claims, damages, losses, costs, or expenses (including personal injury, illness, property damage, or loss of use) arising out of or related to mold, mildew, fungus, spores, or other microbial growth, whether discovered before, during, or after the roofing work. Contractor's scope of work under this agreement is strictly limited to exterior roofing, flashing, and related components. No interior warranty or coverage is provided, and Contractor shall have zero responsibility for interior or consequential damages, whether existing, latent, discovered, or occurring before, during, or after the term of this agreement.

NOTICE TO PROPERTY OWNER

If your contractor or a subcontractor fails to pay suppliers or laborers, your property may be subject to a mechanic's lien. A mechanic's lien is a security interest in the property and may be enforced by foreclosure. This can occur even if you have paid your contractor in full. To preserve your rights, you may require your contractor to provide lien releases from sub-contractors and suppliers.

RIGHT TO CANCEL

You, the owner, have the right to cancel this contract within three (3) business days after signing. Cancellation must be in writing and delivered or mailed to the Contractor at the address listed above. Any payment made shall be returned within 10 days following receipt of the cancellation notice.

DISPUTE RESOLUTION

Any dispute arising out of this contract shall be governed by the laws of the State of California. Venue shall be in the county where the project is located unless otherwise require by law.
