

RESIDENT BENEFIT CARD PERKS AT THE INDIAN WELLS GOLF RESORT

SPECIAL GREEN FEE ON A ROUND OF GOLF:

With a Resident Golf Benefit Card, Indian Wells residents may play the championship golf course at the Indian Wells Golf Resort for just:

- \$50 (January 1 - April 30)
- \$35 (May 1 - December 31)
- \$35 (Walk-up per round, day-of only).

Based on availability. All residents must present their Resident Benefit Card (RBC) at check-in to receive the special resident rates.

Any cancellations or modifications to a resident golf reservation must be handled by 3 days in advance of play by 10 a.m. to avoid charges. A credit card is required to make reservations. The credit card used to make the reservation will be charged \$45 per player for any player canceled inside the cancellation period. Failure to cancel will result in a fully charged fee.



SPECIAL RESERVED TEE TIMES

From October 1 through May 31, the Golf Resort reserves the allocated daily tee times (from 7 a.m. through 1 p.m.) for RBC holders. RBC holders may call (760) 346-4653 or book their times online at www.iwgr.com starting at 6 a.m. 14 days in advance of play. In addition, two days out at 10:00 a.m., which will not appear online, any unsold nonresident and RBC holder tee times will be available to any booking group. Any unsold hotel tee times will be released at 10 a.m. the day before. These times will not appear online and would be available by calling (760) 346-4653.
