SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS AND TO PHASE 2 ANNEXATION FOR MT. WOODSON RESIDENTIAL COMMUNITY

This First Amendment is made, with reference to the following facts:

- A. DAVIDSON COSCAN PARTNERS, a California general partnership ("Declarant") has executed, acknowledged and caused to be recorded the following instruments:
 - (i) That certain Declaration of Restrictions For Mt. Woodson Residential Community filed for record on May 22, 1991 as Document No. 1991-0242593, Official Records of San Diego County, California (the "Declaration"); and
