

#### **AREA OVERVIEW**



The City of Blythe is a General Law city which was incorporated in 1916. It is located 225 miles east of Los Angeles and 150 miles west of Phoenix, Arizona. The Colorado River embraces the east side of the Palo Verde Valley. The City has a Council-Manager form of municipal government. The City Council appoints the City Manager who is responsible for the day to day administration of City business and the coordination of all departments. The City of Blythe encompasses an area of approximately 26.8 square miles and is situated 265 feet above sea level.

Agriculturally based but heavily influenced by tourism, Blythe is located on the California-Arizona border where Interstate 10 crosses the Colorado River. Blythe's population more than triples during the winter months with the arrival of visitors seeking relief from their cold climate home states during that season.

In the summer, in spite of extreme high Sonoran Desert temperatures, Blythe is a center for water sports along the Colorado River. Blythe is a small town and the people are very friendly. Blythe's educational system offers students facilities from pre-school through community college.


PLAT MAP | APN: 848-150-002




