
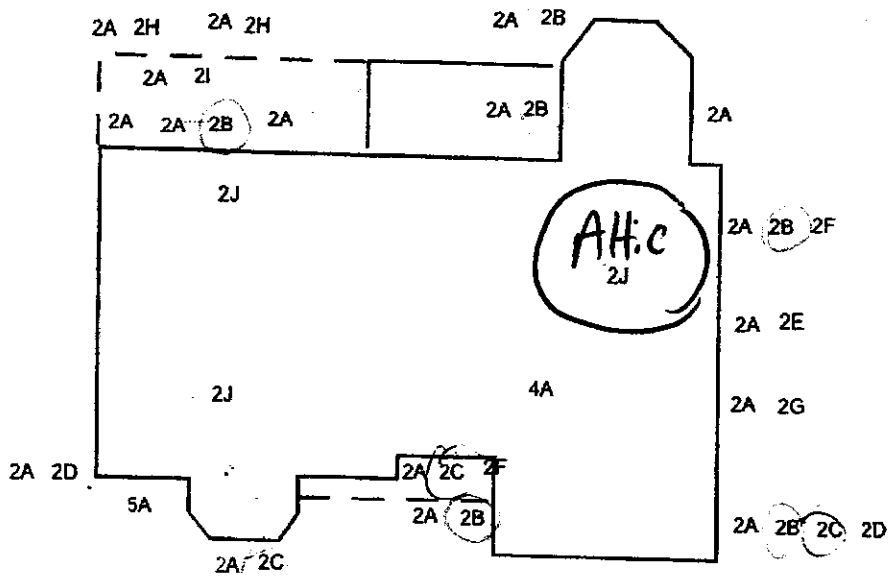

- 5) KEYS TO THE PROPERTY

If any of the above are not in our possession at least 48 hours prior to the start of the fumigation, this could result in cancellation of the job.

Fumigation is covered by a three year guarantee for drywood termites.

Owner to trim plants prior to fumigation to minimize plant damage. We are not responsible for any plant damage. Plants to be trimmed back from structure at least 12" prior to fumigation. All interior plants to be removed prior to fumigation.

Payment is expected at time work is performed.

Fumigation Company will schedule the Gas Company to shut gas off for fumigation. Owner to make access to exterior meter so that Gas Co. technician has access to meter. Owner to contact Gas Co. to schedule the restart of their gas service. (Please note: If your property has a multi-header gas meter, you will be required to get your neighbor's permission to have their gas shut off during your fumigation. If you do not get their permission, or they do not allow shut off, your fumigation will be

cancelled.) This is per the Gas Co. rules and regulations.

During the fumigation, commercial fans will be used to assist in gas distribution. The gas that is used does not leave a residue, however, household dust may settle. We will not be responsible for any cleaning of household dust. Gates may need to be left open by fumigators during fumigation in order to have tent come down side of structure.

Owner / agent / occupant to have attic access open prior to fumigation or treatment in attic. If hatch is not open and we need to open it for fumigation or for treatment, we will not be responsible for any damage to access hatch, paint, handle, and ceiling. Owner to repair if necessary.

ELECTRICITY MUST BE ON FOR FUMIGATION. If the fumigators arrive and cannot do fumigation because owner/agent has not had electricity turned on, fumigation will be cancelled and we will charge \$100 cancellation fee/ rescheduling fee.

If the owner / occupant would like termite pellets to be covered/masked/removed after fumigation, please advise our office and we will quote our cost for doing this. We recommend that this be done as soon after fumigation as possible.

Ventura Pest Control /Fumigators are not responsible for any satellite dishes, antennas, solar panels, roof vents or roofing.

Fumigation jobs are completed by a subcontractor

Ventura Pest Control has a limited number of portable alarm systems that can be used for fumigations. The cost for this is \$100 and will be added to your invoice if you choose to use one of our alarms.

Upon your request, Ventura Pest Control (or fumigation crew) will place a portable motion-activation alarm system into the above property during the fumigation. If an alarm sounds, the local police, fumigation company and contact person for the property will be notified.

Please note that this is being used at your request and we cannot guarantee security of the above property. It is a warning device that will sound if triggered. Ventura Pest Control, Inc. and its fumigation sub-contractors do not assume any responsibility for the care and custody of the property in the event of vandalism, theft or breaking and entering by third parties during the fumigation process.
