PURPOSE:

The Client is advised that certification of repairs, as defined in the Professional Engineers Act, Section 6735.5 of the California Business and Professions Code, constitutes an expression of professional opinion and does not constitute a warranty or guarantee, either expressed or implied. The engineer of record for these services is Trent Burdeno, R.C.E. #C87361. The certification report is for the sole use of the Client and is not transferable. SD Engineering does not intend that anyone other than the Client will rely upon this report, therefore, it is intended solely for the Client, to the exclusion of all others.

SCOPE:

The scope of work includes, and is limited to, revisiting the site to visually observe the repair work and providing a written certification report upon completion of the repair work. The certification will be based solely upon a visual examination of the repair work.

REPORT RELIANCE:

SD Engineering previously evaluated the condition of the foundation and issued a report.
