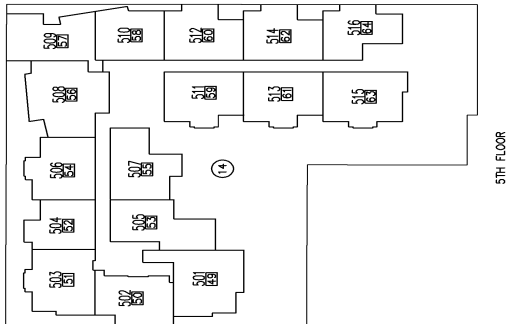

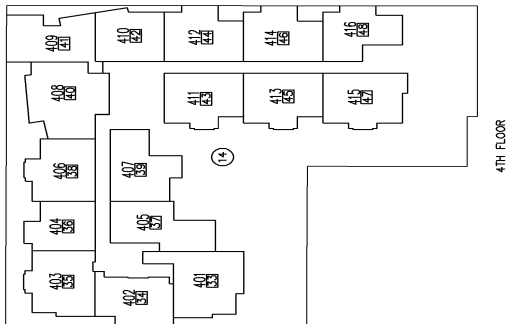

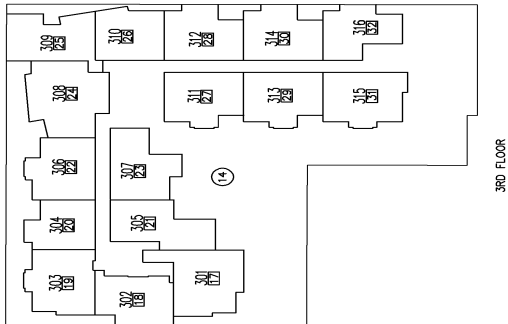
SAN DIEGO COUNTY ASSESSOR'S MAP
