

A. Certain areas are recognized by the industry as inaccessible and/or for other reasons not inspected. These include but are not limited to inaccessible and/or, insulated attics or portions thereof, attics with less than 18" clear crawl space, the interior of hollow walls; spaces between a floor or porch deck and the ceiling below; area where there is no access without defacing or tearing out lumber, masonry or finished work; areas behind stoves, refrigerators, or beneath floor coverings, furnishings; areas where encumbrances and storage, conditions or locks make inspection impractical; and areas or timbers around eaves that would require use of an extension ladder. This report does not include areas behind insulation. Those areas will be inspected, if requested, at an additional charge.

B. Slab floor construction has become more prevalent in recent years. Floor coverings may conceal cracks in the slab that will allow infestation to enter. Infestation in the walls may be concealed by plaster so that a diligent inspection may not disclose the true condition. These areas are not practicable to inspect because of health hazards, damage to the structure, or inconvenience. These were not inspected unless described in this report. We recommend further inspection if there is any question about the above noted areas. Ref: Structural Pest Control Act. Article 6, Section 8516(b), paragraph 1990 (i). Amended, effective March 1, 1974. Inspection is limited to disclosure of wood destroying pests or organisms in the Structural Pest Control Act, Article No. 6, Section 8516B. Paragraph 1990-1991.

C. This inspection pertains only to the specific address or addresses indicated above and does not include any attached or adjacent unit(s).

D. A reinspection will be performed, if requested within four (4) months from the date of the original inspection, on any corrective work that we are regularly in the business of performing. If CERTIFICATION is required, then any work performed by others must be CERTIFIED by them. There is a reinspection fee.

E. This company DOES NOT GUARANTEE work performed by others, including owner. Licensed Contractor's bills should be submitted to escrow as guarantee of work

completed. RODENT PEST TECHNOLOGIES, INC. ACCEPTS NO LIABILITY FOR WORK PERFORMED BY OTHERS.

F. Should any party in interest desire further information pertaining to the condition of the plumbing or the roof, we recommend the employment of a licensed contractor as this is not within the scope of our license.

G. This proposal does not include painting, staining, or decorations in the process of work performed. Items recommended will be replaced as close as possible to original but are NOT GUARANTEED to match.

H. Second story stall showers are inspected but NOT WATER TESTED unless there is evidence of leaks in ceilings below. Ref: Structural Pest Control Rules and Regulations Sec. 8516G. Sunken or below grade showers are not water tested due to their construction.

I. If during the course of or after opening walls or any PREVIOUSLY CONCEALED AREAS any further damage or infestation is found, a supplemental report will be issued. Any work completed in these areas would be at OWNER'S DIRECTION AND ADDITIONAL EXPENSE.

J. During the process of treatment or replacement it may be necessary to drill holes through ceramic tiles or other floor coverings: these holes will then be sealed with concrete. We assume NO RESPONSIBILITY for cracks, chipping or other damage to floor coverings. We do not relay carpet.

K. We assume NO RESPONSIBILITY for damage to any plumbing, gas or electrical lines, etc., in the process of pressure treatment of concrete slab areas or replacement of concrete or structural timbers.

L. When a fumigation is recommended we will assume NO RESPONSIBILITY for damage to shrubbery, trees, plants, TV antennas or roofs. A FUMIGATION NOTICE will be left with or mailed to the owner of the property, or his designated agent, which states, among other things, that ALL FOOD AND MEDICINES must be removed from the premises PRIOR to fumigation.

M. Your termite report and clearance will cover any EXISTING infestation or infection which is outlined in this report.

N. If you should have any questions regarding this report, please call or come by our office any weekday between 9:00 a.m. and 5:00 p.m.

O. I agree to pay reasonable attorneys' fees if suit is required by this COMPANY to enforce any terms of this contract, together with the costs of such action, whether or not the suit proceeds to judgment.

P. The total amount of this contract is due and payable upon completion of work unless otherwise specified. A finance charge computed at a monthly rate of 1.5% of the unpaid balance (annual percentage rate 18%) will be added to all accounts past due.

Q. If this report is used for escrow purposes then is agreed upon that this inspection report and completion, if any, is a part of the ESCROW TRANSACTION.

R. Permit fees and engineering fees are not included. If required, obtaining and paying for permits and engineering fees will be the responsibility of the owner.
